



FREQUENTLY ASKED QUESTIONS ABOUT PROFESSIONAL ACCREDITATIONS 2023

What does the professional accreditation include?

- o Festival welcome pack.
- o Access to DocsBarcelona&Me where you will find all the contacts of the attending professionals.
- o Access to all conferences, workshops and Master Classes and to exclusive activities for accredited people. (Subject to capacity)
- o Access to funding activities: Public Pitch and Rough Cut Pitch. (Presence and Streaming)
- o Access to exclusive networking activities for accredited individuals.
- o Access to the Video Library.
- o Access to in-person festival screenings. (Subject to capacity. Does not include opening/closing events or sessions in Filmoteca)

What does the student accreditation include?

- o Festival welcome pack.
- o Access to all conferences, workshops and Master Classes and to exclusive activities for accredited people. (Subject to capacity)
- o Access to financing activities: Public Pitch and Rough Cut Pitch. (Presence and Streaming)
- o Access to the Video Library.
- o Access to in-person festival screenings. (Subject to capacity. Does not include opening/closing events or sessions in the Film Library)

I participated in DocsBarcelona last year and I am already registered in DocsBarcelona&Me. What is the procedure for me this year?

Log in with your e-mail and password to DocsBarcelona&Me, once inside, select the accreditation that suits you best and make the payment. Remember to assign your data to the accreditation.



Which payment methods are available?

You can pay by credit or debit card and PayPal.

Will I receive a receipt / invoice for my accreditation fee?

Yes. Once payment is completed, borrowers will receive an invoice by email. For billing inquiries, you can write to molivella@parallel40.com with all billing details.

How can I access the movies?

Within your DocsBarcelona&Me profile, access to "FILMS" will be activated once the accreditation has been purchased. There, you can see all the films of the festival. If you want to attend the screenings in person, you must use the accreditation code to redeem a free ticket. Check how to do it [HERE](#).

Will I need the accreditation to access industry activities?

Yes, except for the following which are also open to the general public:

- o Character Driven Documentary | Polish Prayers
- o Documentary Filmmaking | Vitaly Mansky
- o Case Study Disney

Can I access all industry activities with my accreditation?

No, Speed Meetings are only for selected participants and the Archives Meeting is a private event. Student credentials do not have access to Networking activities. The opening and closing are also excluded from accreditation.

Where do DocsBarcelona's industry activities take place?

Various spaces of the CCCB and some can be followed in streaming through the DocsBarcelona&Me platform. In addition, other activities will be recorded and uploaded to DocsBarcelona&Me.



I have an accreditation. Where can I collect it?

The accreditation for DocsBarcelona 2023 is online and can also be collected physically at the counter located in Teatre CCCB during the following hours:

- o Wednesday May 17: 10am to 2pm and 4pm to 7pm
- o Thursday 18 May: 10am to 2pm
- o Friday May 19: 10am to 2pm and 4pm to 7pm
- o Monday May 22 to Saturday May 27: 10 am to 2pm and 4pm to 7pm
